'My offers' in Introducer Internet

- You can download and print an intermediary copy of your client's mortgage offer as soon as we've issued it.
- Introducer Internet displays all active offers issued in the last 180 days where the application hasn't completed.
- Mortgage offers are displayed in 'Case Reference' descending order.
- Where multiple mortgage offers have been issued these will be displayed in 'Offer Date' order.
- We'll send you a Mortgage Application Tracking System (MATS) message as soon as we've issued the offer. This will include the solicitor details if it's a remortgage offer with standard legal fees paid.




Name of first customer will be displayed in the 'Customer Name' field.

If a 'Case Reference' has a 'C' suffix, this will not be displayed in the field.
